

Spooky Halloween Search How to Win / Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Sweepstakes is open only to legal residents of Colorado who are 18 years or older. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED AND OUTSIDE COLORADO.

1. Sweepstakes Name: Spooky Halloween Search (the "Sweepstakes")

2. Sweepstakes Dates/Registration Period: The Sweepstakes is scheduled to begin 10/1/09 at 12:00am MST and end 10/31/09 at 11:59pm MST (the "Registration Period"). Sponsors' clock shall be the official time piece of the Sweepstakes.

Scream Green with Arc Thrift Stores, Avocet Communications, KDVR, KWGN, Genuine Buddy 50 Scooters, and Sportique Scooters ("Sponsors"), their subsidiaries and affiliated companies, will conduct the Sweepstakes substantially as described in these rules, and by participating, each participant agrees as follows:

3. How to Enter – Two Ways:

Online Registration

To enter, visit www.kdvr.com or www.2thedeuce.com during the Registration Period and click the Sweepstakes link. In order to enter the sweepstakes for a chance to win the grand prize, each contestant must complete all rounds of the game by correctly or incorrectly solving the differences between (2) pictures.

Alternate Entry: To register for the Sweepstakes without playing the puzzle game, simply click the following link which will direct you to the Sweepstakes registration page: <http://www.mdmgames.com/spookydenver>. Any entrant who advances to the Sweepstakes registration page will be required to enter their name, address, birth date, phone number, valid email address and answer the Sponsors' survey question.

Maximum of one entry per person or per valid email address during the Sweepstakes period. Each participant must submit an entry on their own behalf. Any entry submitted by a contestant on behalf of another individual or using another person's email address or name will be disqualified and ineligible to claim any prize. Onsite Registration

To enter in person, visit any Arc Thrift Stores in the Denver Metro area including Loveland, Ft Collins, and Greeley or our 4 stores in the Colorado Springs/Pueblo area during the Registration Period and regular business hours. See the Arc Thrift Stores website for a list of stores. In order to enter the sweepstakes for a chance to win the grand prize, each contestant must complete an entry form provided by the store.

Maximum of one entry per person during the Sweepstakes period. Each participant must submit an entry on their own behalf. Any entry submitted by a contestant on behalf of another individual will be disqualified and ineligible to claim any prize.

4. Winner Selection & Notification: On or about 11/4/09, (4) separate random drawings will be held to select a total of (4) potential Grand Prize winners (see Grand Prize description below):

- (1) from among the POP at the Northern Colorado Stores: Greeley, Ft Collins, Loveland

Odds of being selected as a Grand Prize winner are dependent upon the total number of eligible entries received from that particular entry method. Decisions of the Administrator in the selection and determination of Grand Prize winner and, all matters relating to this Sweepstakes, are final and binding.

The potential Grand Prize winners will be notified initially by phone beginning on or about **11/6/09**. If the Administrator is unsuccessful in its attempts to reach and speak directly with a potential Grand Prize winner by phone after three attempts over a 72-hour period to the phone number listed on that entrant's entry, then that entrant will be disqualified and, at Administrator's discretion, an alternate potential Grand Prize winner will be randomly selected from among the remaining eligible entries and notified as per the procedures outlined above (time permitting).
